- ▶ Please note this is an annual report based on a calendar year.
- ▶ Mark the appropriate box(es) on the front of the form to describe the status of the mine during the year. If abandoned during the year, please give the date.
- ▶ If the mine was sold during the year, please give the date of sale and specify to whom the mine was sold. Also complete the appropriate section(s) for the months your company operated the mine.
- ▶ If your company is contracting out mining work, or if your company is the subcontractor, please check the box and supply the necessary information.
- ▶ Underground-mine operators and/or subcontractors should complete Sections 1, 2, and 4.
- ▶ Surface-mine operators and/or subcontractors should complete Sections 1, 2, and 5.
- ▶ Non-mining facility operators (preparation plants, tipples, shops, etc.) with facilities not part of a mining operation should complete Section 3. If the facility is at the mine site, the appropriate information should be completed in either Section 4 or Section 5.
- ▶ **If this operation produces industrial minerals, this industrial mineral production must be reported on an Industrial Mineral Report form. Please call J. D. Stucker at (614) 265-6601 for an industrial-mineral reporting form. You may download the form in PDF format at www.OhioGeology.com.**
- ▶ Report tonnages to the nearest whole ton. One short ton equals 2,000 pounds.

SECTION 1. IDENTIFICATION

- ▶ Include the ODNR Division of Mineral Resources Management (DMRM) permit number for the mine along with the “old” Division of Mines number, if you know it. The mailing label should include the mine’s correct DMRM permit number (begins with D-, *i.e.*, D-0799) and its “old” Division of Mines number (begins with alphabetical county abbreviation, *i.e.*, BT-105). Please make any corrections necessary.
- ▶ If your company uses a separate pit name to identify the mine, please include this name in the space marked “Mine name.”
- ▶ If the mine has an address, please include this under “Mine location.” If the mine has no address, please give general directions to the mine.
- ▶ Please include the location of the mine in the spaces marked “County(ies),” “Township(s),” and “Section(s).” If production occurred in more than one county, please list all counties and townships in the space provided.

SECTION 2. DISPOSITION

- ▶ *Disposition*—Indicate method(s) of shipment of coal. Do not include reject or waste material in this category. The total tonnage reported in the *Disposition* category should reflect the total tonnage sold from both new annual production and existing stockpiles, and does not necessarily have to equal the total tonnage produced as reported in Sections 4 or 5.
- ▶ *FOB (free on board) sale value*—Indicate the total market value, to the nearest whole dollar, of all tonnage sold during the year. Do not include any transportation costs.
- ▶ If assistance is needed in identifying the seam(s) of coal being mined, please contact the Ohio Division of Geological Survey.
- ▶ If production occurs in more than one county, indicate either a by-seam tonnage breakdown for the counties involved, or the percent production from each county.

SECTION 3. NON-MINING FACILITY

- ▶ This section applies only to preparation plants, shops, tipples, etc. that are not on-site facilities for a mining operation. Any non-mining facility that is located on the site of a mining operation should complete the appropriate parts in either Section 4 or Section 5.
- ▶ *Identification*—See instructions for Section 1.
- ▶ *Coal washing*—Indicate raw tons before washing and clean tons after washing for both underground-mined and surface-mined coal. Indicate raw tons and clean tons by seam also, if possible.
- ▶ *Employment*—See employment instructions for Section 4 and Section 5.
- ▶ *Gross wages and salaries*—Give the total gross wages and salaries for all employees for the year (W-2 earnings), to the nearest whole dollar.

SECTION 4 AND SECTION 5. UNDERGROUND MINING OR SURFACE MINING—PRODUCTION AND EMPLOYMENT

- ▶ *Production*—All production totals should be equal. When possible, clean (washed coal) tons should be used for production. Do not include any reject or waste material in this category. Indicate the tonnage produced by mining method, the tonnage produced by month, and a by-seam breakdown of the tonnage produced. When the coal produced has been washed, please give a by-seam breakdown of washed coal (raw and clean tons). Total clean tons plus unwashed coal should equal total production. If the coal is washed somewhere other than at the mine site, please indicate the operator of the prep plant.
- ▶ *Employment*—*Underground mining employees* should include all employees involved with the actual production of coal underground that do not belong in any other employee category. *Surface mining employees* should include all employees involved with the actual production of coal on the surface (strip, highwall, and auger mining) that do not belong in any other employee category. *Non-production employees* include the following: *Preparation plant, tipple, shop, etc.* employees should include all employees directly involved in the operation of these facilities that do not belong in any other employee category; *supervisory, technical, clerical* employees should include all supervisors, engineers, secretaries, etc. that are employed at the mine; *reclamation* employees should include all employees involved in reclaiming the mine site; and *other* employees should include all employees during the year who do not belong in any other employee category, such as mobile equipment operators, mechanics, or general outside.
- ▶ *Productivity*—Give the total number of days each month that coal was produced at the mine.
